Statement by the Eastern Partnership Civil Society Forum Georgian National Platform

Members of the Eastern Partnership Civil Society Forum –Georgian National Platform state their deep concern over the latest developments on the occupation line with breakaway South Ossetia.

Over the past week, the Russian occupation forces have stepped up the process of setting up barbed wire fences across the administrative dividing line, moving the occupation line forward by several hundred meters in some areas. This has had grave consequences for the residents of the areas adjacent to the occupation line.

In the village of Dvani, almost half of the residents have reportedly lost their agricultural lands, thus their only income source as well as food reserves for winter. On the 23 of September, the occupation forces reportedly obliged the residents of Dvani in a short time period to leave their houses and/or harvest crops from their lands on the other side of the redrawn occupation border.

The process of shifting of the occupation line, while being conducted in violation of international law and the 2008 Ceasefire Agreement, has also resulted in gross violations of the rights of the residents of adjacent areas.

Despite the efforts of the international community, the government of Georgia and local civil society organizations, the process of constructing different types of barriers, started in 2009, has been intensified since the beginning of 2013. A shift of the occupation line left the objects of crucial importance to the local

population, such as drinking water supply and irrigation beyond their reach. We believe these actions serve the goal of oppressing the local community and forcing them to vacate the villages adjacent to the conflict zone, further reinforcing the occupation of Georgian territories.

There are the incidents of the purposeful pursuit of ethnically Georgian population on the occupied territory.

We therefore call upon the European Union to condemn these illegal actions by the occupation forces and to take effective measures toward the protection of the rights of affected people and sovereignty of Georgia. Moreover, activation of the international mechanisms to ensure security and protection of the rights of those affected is essential.
